SUBJECT: Full Day Kindergarten Class Size

I am writing to inform you about changes to Ontario Regulation 399/00, Class Size, impacting Full-Day Kindergarten classes. Specifically, the changes require school boards to organize FDK classes to an average size of 26, effective September 1, 2012.

As you are aware, the Full Day Kindergarten (FDK) program was announced in October 2009 with a class size delivery model of 26:2 (twenty-six pupils and a teacher and early childhood educator). With two qualified professionals in the room, FDK classrooms have an adult to child ratio of approximately 1:13.

The FDK funding framework and EPO contract, as well as ministry communication to school boards, have consistently reflected the intent to implement the program model of 26:2. However, the ministry is aware that there have been some challenges associated with the implementation of this model during the first two years of rollout.

While the government is committed to respecting the terms of existing collective agreements, it is important to move forward with a sustainable plan that is consistent with the announced policy direction and funding framework for the program. This is why the government recently amended O. Reg 399/00 to include s. 2.1 under *Elementary School Classes – Requirements Respecting Size*. This section provides class size provisions for full-day junior kindergarten and kindergarten, clearly identifying an average class size unit of 26 pupils.

Although changes will not be effective until September 1, 2012, the government has made these amendments now to provide boards with the information needed to finalize staffing decisions for the 2012-13 school year.

Additional administrative amendments to O. Reg 399/00 have been made to clarify the

applicability of the new requirement. The requirement to organize FDK classes to an average size of 26 applies to schools included in the roll-out schedule provided in the table of Ontario Regulation 224/10, *Full Day Junior Kindergarten and Kindergarten*. Consequently, a provision has been added to reflect that, as of September 1, 2014, all boards will be required to offer FDK and will be subject to the new requirement.

I would like to take this time to thank school boards for keeping the Ministry informed about the Full Day Kindergarten class size challenges you may have faced this year, and I look forward to working with you and with our stakeholders to ensure the continued success of this program.
